PART B: PROJECT CONTEXT

Introduction:

Tibetan Homes Foundation (THF) is a registered charitable institute dedicated to working for the care of orphan, semi-orphan and destitute Tibetan refugee children. More than five decades have gone by since its small beginning in November 1962 at Mussoorie by His Holiness Tenzin Gyatso the XIVth Dalai Lama. Tibetan Homes Foundation has been taking care of Tibetan refugee children in exile and senior citizens under its old age homes. The institute as a whole tries to work effectively with its mission to care for the Tibetan refugee children in exile under its care, to provide with the best possible means of good education so that these children grow up as self reliant and contributing members of community at large, to impart and inculcate the rich traditions, moral values and cultural heritage of Tibet to preserve and promote our Tibetan identity that faces great danger of being wiped out, to provide a good care needed for senior citizens who are left on their own at the evening of their life, and to render other social services in the form of "Outreach Community Program

Project Summary:

The school has a small clinic with a capacity of 50 inpatients with a residence doctor and a team of health workers and nurses to take care of children. The school clinic also has a small dental clinic where dental care to children were given by a dental hygienist cum therapist till date. We are glad that this year an ex-student of our school has come back to serve the institute. He pursued his higher studies in dental course and has successfully completed his Bachelor in Dental Surgery with a year of experience. He joined our school from the beginning of this year and was effectively looking after the dental care of our children. Since the school does not have dentist before, all the cases were referred to local dental hospital with no proper equipments in the school dental clinic. We are trying to equip the dental clinic with all the necessary equipments so that it can effectively serve all the children, staff and elderly under the care of Tibetan Homes Foundation.

Why the project need?

The school dental clinic was looked after by a hygienist with the refer of dental problem patients to a local dental hospital. But now, an ex-student has joined to serve alma mater after successfully completing his Bachelor's course in Dental Surgery. We are trying to equip the dental clinic with the basic necessary equipments so that our dentist can work effectively taking care of children, elderly and staff under the care of Tibetan Homes Foundation.
